*It hails from the Sanskrit **lun̥h** to Hindi **lūṭ**, into early 19th century **loot**, describing goods of considerable value usually taken in conquest, war, or after destruction (i.e., to rob). Unsurprisingly, if we push farther back in time, **lūṭ/loot** traces back to the Sanskrit **lotram** (plunder). **Loot** enters the English language through books and manuscripts developed during the British colonization of the Indian subcontinent — the transfer of wealth part of the celebration of victory. **Looting** has evolved to describe rioters looting stores (during political upheaval, national disasters and emergencies), art heists, and grave robberies to name a few.
